4b (Code:) (Expenses \$ 17,068 including grants of \$) (Revenue \$ 13,374) CERTIFICATION AND EVALUATION SYSTEM: Created certification standards for ASL Teachers and certify those teachers meeting standards. ASLTA has been certifying teachers of ASL since 1976. Certification insures teachers possess the skills and knowledge to teach ASL and the culture of the American Deaf community, encourage and reward professional growth, and encourage participation in the ASLT organization and profession. Revised the procedures and standards to better meet current standards in the field.
