ADDENDUM

You formed October 2, 2003, and filed your Form 1023, Application for Recognition of Exemption Under Section 501(c)(3) of the Internal Revenue Code, on December 23, 2011. You failed to file a required annual return or notice (Form 990, Form 990-EZ, Form 990-PF or Form 990-N) for three consecutive years after you were formed and while your application was pending. As a result, your tax-exempt status was automatically revoked on May 15, 2010, the due date of your third year return or notice. We are treating your Form 1023 as an application for reinstatement and are recognizing your exemption as reinstated on the same day it was automatically revoked. As a result, you are recognized as tax-exempt continuously from the effective date of exemption as reflected at the top of this letter.

This supersedes our letter dated March 7, 2012, which did not include the above addendum regarding auto revocation. We have updated our records to reflect this change.

This letter supersedes our letter dated July 16, 2014 which was issued with an incorrect address. We have updated our records to reflect the proper address as shown in the heading of this letter.
