


#### Letters to the Editor





## NC REQUIRES ASLTA PROVISIONAL CERTIFICATION FOR LICENSURE

State of North Carolina Department of Public Instruction's Standards for Teachers of American Sign Language and Standards for American Sign Language Levels 1 and 2 was approved by North Carolina State Board of Education on June 5, 2007.

They also passed the requirement of a 4 year degree and an ASLTA Provisional Certification or a 4 year degree in ASL and an ASLTA Provisional Certification, said Dr. Rachael Ragin, consultant in Deaf Education and Audiology for Exceptional Children Division in the NC Dept. of Public Instruction. She spearheaded the NC standards committee which included several ASLTA certified members: Cindy Decker-Pickell, James M. Wilson and Keith M. Cagle.

Also both houses of NC State Legislature passed the ASL Bill unanimously in the spring legislative session to encourage high schools, community colleges and universities to offer the ASL courses.

NC State Governor Mike Easley signed the bill into the law on June 29, 2007.



#### **Career Tips**

While it is possible to teach in community education programs with little formal training, it is almost impossible to get hired by colleges and universities without at least a Masters and a specific number of credits (usually 15-20) in the ASL/Deaf Studies content area.

In the past it was possible for colleges and universities to hire someone as an "expert in the field" even if they did not have the formal background, but it always required a great deal of documentation and paperwork on the part of the college.

Now that the primary accreditation agencies such as SACS and NCACS are cracking down on colleges and universities all over the country, it is becoming more and more difficult to get hired without a formal degree.

## Certification Issues Professional Development Interviews

ASLTA Professional Interviews will be offered at NAD July 2008 conference in New Orleans and at the CIT October 2008 in Puerto Rico, provided there are enough candidates to fill the slots.

ASL literature competition is open to ALL levels of signers with the possibility of monetary prizes to the top in each division




