RECOGNITION OF ASL: 50 YEARS IN THE MAKING



Opening Ceremony Speaker
Dr. Carol Padden

Dr. Carol Padden received a B.S. (1978) from Georgetown University and a Ph.D. (1983) from the University of California, San Diego, where she is currently a professor in the Department of Communication and associate dean for the Division of Social Sciences. publications include the co-authored volumes Deaf in America: Voices from a Culture (1988), Inside Deaf Culture (2005), two textbooks on American Sign Language, and scholarly articles in such journals as PNAS, the Journal of Linguistics, and the Journal of Developmental and Behavioral Pediatrics. In 2010, the John D. and Catherine T. MacArthur Foundation named Carol Padden a recipient of its so-called "genius" grant. The foundation recognized Padden's pioneering work in the morphology and evolution of American Sign Language with a no-strings attached grant of \$500,000.





Closing Ceremony Speaker Dr. Raychelle Harris

Third generation Deaf and a native ASL signer, Raychelle received her BA in American Sign Language Studies from Gallaudet University and MS in Deaf Education from Western Maryland College in 1995 and 2000, respectively. Prior to her doctoral studies, she worked as an ASL specialist at New Mexico School for the Deaf, and as a part of a team, implemented new school-wide ASL assessment tools and 7th/8th grade ASL curricula. As a committed advocate of social justice, Raychelle co-presented and coauthored several publications about ethics of research in Sign Language communities, with Heidi Holmes and Dr. Donna Mertens. Raychelle's current dissertation study analyzes the construction and use of extended discourse (in other words, academic discourse) in a bilingual ASL/English preschool setting with Deaf teachers and students. On a personal level, Raychelle is an outdoor enthusiast, a treehugger and an advocate for deaf animals.

Changemaker presenters include Dr. Amy June Rowley, Dr. Amy Hile, Dr. Joseph Hill, Dr. Sean Virnig and more!



CHANGEMAKER SESSIONS





Dr. Amy June Rowley is the Coordinator of the American Sign Language program in Modern Languages and Literatures department at California State University Easy Bay. She is currently working on her dissertation in Second Language Education in Urban Environments from the University of Wisconsin, Milwaukee. She holds a Professional level certification from ASLTA. Her research interests are children in special education litigation; the systemic and hierarchal structure of ASL programs in postsecondary institutions; and relationships between students/interpreters and the Deaf community.



Dr. Amy Hile

Dr. Amy Hile was hired as a faculty member in the Department of Education at Gallaudet in August 2006. Originally from the Twin Cities area in Minnesota, Amy received her Ph.D. from the University of Colorado at Boulder. Her doctoral studies center around the areas of ASL Development/Acquisition, Fingerspelling, and K-12 ASL/English Bilingual Education. Previously, Amy taught at the elementary level at the Metro Deaf School (MDS), the nation's first Deaf ASL/English Bilingual charter school in Saint Paul, MN from 1993 to 2000. When Amy is not busy working, you may find her reading novels, quilting, traveling, and walking/hiking with her dog, Chey, among many other things.



Dr. Joseph Hill

Dr. Joseph Hill is an assistant professor at the University of North Carolina at Greensboro. He works in the Professions of Deafness programs in the Department of Specialized Education Services. He was born and raised in Cincinnati, OH in a family of hearing and deaf members. Dr. Hill went to Gallaudet University in Washington, D.C. where he studied linguistics of ASL for both his master's and doctorate degrees. He is one of the co-authors of *The Hidden Treasure of Black ASL: Its History and Structure*. He is proud to be a part of the Black ASL research team because the history and language of the African-American Deaf Community deserves a closer look from the scholarly perspective.



Dr. Sean Virnig

Dr. Sean Virnig is a native of St. Paul, Minnesota and is the first Deaf superintendent of the California School for the Deaf, Fremont (CSD), where he graduated as class valedictorian in 1992. Virnig had been the director of education for the Texas School for the Deaf in Austin until his CSD selection. Prior, he was director of strategic projects at the Minnesota State Academies for the Deaf and the Blind, director of education for the Minnesota State Academy for the Deaf, K-12 principal for the same academy, public policy specialist with the Minnesota Department of Human Services, education specialist for the University of Minnesota, and a classroom teacher at the Minnesota State Academy for the Deaf. He is currently completing his Ph.D. in Educational Policy and Administration, also from the University of Minnesota.

- **2.** Members were contacted to notify them of the current membership cycle and any past due memberships they may owe. [Note: Certified members are required to pay dues annually to maintain valid ASLTA teacher certification.]
- 3. Since April 1, 2014 ASLTA has collected \$51,617 in current and past-due memberships.

A candidate with a Qualified certification may request for an interview at any time of year, rather than wait for next biennial ASLTA conference. Due to the ASLTA website not being fully functional, any candidate who wants to make a payment for either an evaluation, a renewal, or an extension fee, they will need to contact our treasurer Bill Newell directly for the time being. He will assist members with making payments.

Keeping current with an ASLTA membership annually is **very** important in order to maintain a valid certification. After August 31, 2015, all invalid certifications will be permanently revoked. Please use the remainder of this membership cycle, until August 31, 2015 to catch up on membership dues.

IN MEMORIAM

Alysse Suzanne (Funk) Rasmussen



Alysse Suzanne (Funk) Rasmussen, Ph.D, was born June 16, 1951 in Rockford, Illinois and passed away December 15, 2014 in Orlando, Florida from a liver dysfunction that had afflicted her over the past year.

At the time of her death, Alysse worked for the Florida Coordinating Council for the Deaf and Hard of Hearing as a Health Educator Consultant acting as an outreach specialist. In addition, she was an Adjunct Professor of Education at Valencia College in Orlando, FL.

Alysse was a life-long learner, earning her Bachelor's degree in Linguistics and Spanish in 1978 from the University of Madison in Wisconsin, her Master of Arts degree in Learning & Technology in 2004 from Western Governors University in Salt Lake City, Utah, and her Ph.D. in Applied

Linguistics (Dissertation: Assessing Interpreter Intercultural Sensitivity) in 2012 from Union University in Cincinnati, Ohio.

Alysse was an excellent and dedicated teacher, having taught a variety of linguistic subjects including Spanish, English as a Second Language, American Sign Language, and many other courses from 1974 until her death. Although she was a part of the hearing community, her main professional interest was focused on teaching American Sign Language and Deaf culture. She earned her American Sign Language Teachers Association (ASLTA) certificate at the Qualified level. Over the years, Alysse has done numerous presentations at different conferences including Florida American Sign Language Teachers Association (FASLTA), Deaf Studies, ASLTA, and Florida Foreign Language Association (FFLA).

After receiving multiple nominations over a 5-year period when she served on the FASLTA Board as secretary and vice president, in 2007 she was given the Distinguished Service Award from the FASLTA. The

following year, she began her term as FASLTA President until 2013.

At the 2013 ASLTA National conference, Alysse was awarded the T.J. O'Rourke Memorial Award for her contributions to the field of ASL teacher education. Her organizational skills, willingness to dig in to tackle any task, and her upbeat, people-oriented personality made her an ideal volunteer.

Alysse is survived by her husband of 42 years, Daniel L. Rasmussen of Orlando, Florida; her three sisters: Lu-C R. Leisemann of Watertown, WI; Amy D. Sams, Ph.D. of Livermore, CA; and Querida (Q) L. Funk of Oregon, WI; and her nieces and nephews.
